# COIN OF AFRICA (CoA) INITIAL COIN OFFERING (ICO)

Golix has been operational since 2016. It is a profitable and fast growing company that processed its first transaction on September 16, 2016. The below table shows the performance Golix achieved in 2017.

FINANCIAL OVERVIEW

As of 2018, Golix has grown to over 50,000 customers and having transacted over US\$20 million to date. Golix managed to raise just over \$20 million through their GLX ICO. Funds raised by this Coin of Africa (CoA) Initial Coin Offering (ICO) will see Start-Up Nation (SUN) growing the platform locally and expanding into different African countries, as well as expanding their portfolio of services.

Bitcoin achieved phenomenal levels in 2017 reaching heights of US\$20,000/coin and a market cap that exceeded \$500 billion. Bitcoin's major flaw is that it lacks an underlying value therefore making it risky.

CoA is launching with a price of \$0.1080 (10.8c). Private Placement Investors earn a 50% discount/coin. Our initial goal is to get each coin to pass the \$1.00 level. To achieve this, CoA will also be anchored on the productivity of SUNFund. The ICO funds will be used to finance projects in Zimbabwe and other African countries so that the value is backed by performance of these assets – creating a Crypto-Economy.

Our model sees us growing the cryptocurrency value to \$2.00 by Year 10 from the initial price of \$0.1080. This growth will be anchored on the demand for the token as well as the performance of the underlying assets of SUNFund.

# **RISK ANALYSIS**

With every investment there are inherent risks involved. Start-Up Nation (SUN) has however studied the market, run tests, and formulated a structure that mitigates (but does not prevent) the major risk that every investor fears which is – LOSING THEIR CAPITAL!

#### 1) REGULATION RISK

Cryptocurrency is a new invention and Zimbabwe has not yet innovated regulation for it. The Reserve Bank issued a ban on cryptocurrency while the Securities & Exchange Commission of Zimbabwe have distanced themselves from cryptocurrency, however this ban was suspended by the High Court. There are inroads being made into finding ways to regulate cryptocurrencies. Our model ensures that we, SUN, can coordinate and run a successful Initial Coin Offering (ICO).

#### 2) SECURITY RISK

Crypto-wallets, where crypto is stored, are secured with a robust two-factor authentication to ensure that thieves and hackers don't get into your account. The developers of the Waves Blockchain hold sharp skills and value the importance of maintaining high security standards.

#### 3) <u>CAPITAL RISK</u>

The major flaw that Bitcoin has is that it is not backed by anything other than demand for it, this makes it highly speculative. CoA will be anchored on Old Mutual and Productivity to create a portfolio of underlying assets that will affix the value of the coin and create stability.


